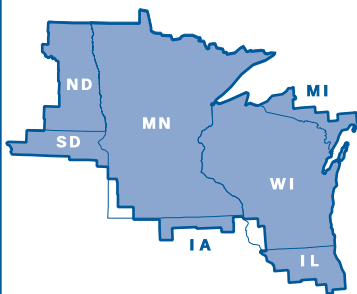

Tentative Partial Decision to Amend the Upper Midwest Order Issued

The U.S. Department of Agriculture recently announced a tentative partial decision that recommends amendments to current provisions of the Upper Midwest Federal Milk Order.

This decision is based on testimony and evidence given at a public hearing held August 16-19, 2004, in Bloomington, Minnesota.

This decision adopts amendments to the performance standards and transportation credit provisions of the order. The amendments include:

- 1) Revising the supply plant performance standards so that milk seeking to be pooled on the order demonstrates consistent service to the Class I market;
- 2) Preventing handlers located within the states that comprise the marketing area (see map to the left) from qualifying milk located outside of these states;
- 3) Eliminating as producer milk diversions to nonpool plants outside of the

states that comprise the marketing area (see map to the left); and

- 4) Establishing a limit so that a transportation credit can only be received for the first 400 miles of any single milk movement.

A separate decision will be issued at a later time that will address proposals concerning the depooling and repooling of milk, temporary loss of Grade A status, and increasing the maximum administrative assessment.

The decision was published in the April 14 *Federal Register*. Interested persons have until June 13 to file comments in response to the tentative partial decision. USDA will determine if producers approve the amended order.

Pool Summary

- In March, 16,154 producers delivered to the market with an average daily delivery of 4,592 pounds.
- Producer milk totaled 2.17 billion pounds, up 1.5 billion pounds from February and 1.5 billion pounds above March 2004.
- Class I utilization totaled 382 million pounds, down 1.0% on a daily basis from February. Class I usage accounted for 17.7% of producer milk.
- The March Producer Price Differential (PPD) is \$0.41 per cwt.
- The Statistical Uniform Price is \$14.49 per cwt., down \$0.03 from February, and \$0.21 below March 2004.
- Market statistics for March are shown on Pages 4 and 5.

Actions in Other Federal Orders

USDA Announces Recommended Decision on Producer-Handlers

The U.S. Department of Agriculture recently announced a decision that recommends amendments to the current provisions of the Pacific Northwest and Arizona-Las Vegas Federal Milk Orders.

This decision is based on testimony and evidence given at a public hearing held at Tempe, Arizona beginning on September 23, 2003; reconvened and continuing at Seattle, Washington on November 17, 2003, and reconvened and

concluding at Alexandria, Virginia on January 23, 2004.

The decision recommends establishing a three million pound per month route disposition limit which, if exceeded, would make a producer-handler subject to the pooling and pricing provisions of the Pacific Northwest and the Arizona-Las Vegas Milk Orders.

The recommended decision was published in the April 13 *Federal Register*.

Interested persons have until June 13 to file comments in response to the recommended decision.

USDA Amends the Pacific Northwest Order on May 1

The U.S. Department of Agriculture recently announced a final rule amending the Pacific Northwest Federal Milk Order effective May 1, 2005.

The amendment had previously been implemented on an interim basis. Producers of the Pacific Northwest Order approved the amended order.

The amendment to the producer milk provision of the order eliminates the ability to simultaneously pool the same milk on the Pacific Northwest Order and a state-operated milk order that has marketwide pooling. The final rule was published in the April 12 *Federal Register*.

USDA Amends the Northeast Order on May 1

The U.S. Department of Agriculture recently announced a final rule implementing amendments to the Northeast Federal Milk Order to become effective May 1, 2005. Producers of the Northeast Order approved these amendments.

The amendments will: revise certain reporting and payment date provisions; establish year-round supply plant performance standards; eliminate the split-plant provision; establish a one day

touch-base provision; establish explicit limits on the amount of milk a pool plant may divert to nonpool plants; exclude milk received by supply plants from producers not eligible to be pooled on the Northeast Order from the total volume of milk used to satisfy supply plant performance standards; prohibit the ability to simultaneously pool the same milk on the order and on a marketwide pool administered by another government entity; and grant authority to the market administrator to adjust the touch-base

standard and diversion limits as market conditions warrant. The final rule was published in the April 12 *Federal Register*.

USDA Sets Hearing on Fluid Milk Product Definition

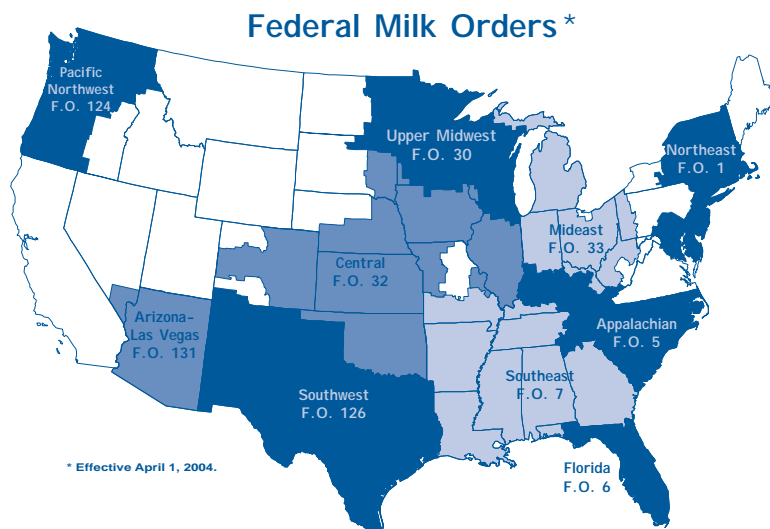
The U.S. Department of Agriculture recently announced that it will hold a national public hearing to consider proposals seeking to amend the Class I fluid milk product definition in all Federal milk marketing orders, including the Upper Midwest Order.

The hearing will begin at 8:00 a.m. on June 20, 2005, at the Sheraton Station Square Hotel, 300 West Station Square Drive, Pittsburgh, Pennsylvania 15219.

The hearing was requested by Dairy Farmers of America, Inc. (DFA), who asked USDA to reconsider which dairy products should be classified as Class I products. DFA contends that many fluid consumable milk products are currently classified as Class II products because of the current formulation standard.

Robert Vander Linden Named Market Administrator of the Central Milk Order

Robert E. Vander Linden was appointed Market Administrator of the Central Federal Milk Marketing Order effective April 3, 2005. He replaces Dr. Donald Nicholson who retired in January. The Central Order is one of the two Federal orders that border the Upper Midwest Order.

Mr. Vander Linden has worked for the

Federal Milk Order Program since March 1969 when he was hired as an Auditor in Des Moines, Iowa. In 1978 he was promoted to the position of Computer Programmer for the Kansas City Market Administrator's Office.

He was promoted to Assistant to the Market Administrator in 1986 and to Assistant Market Administrator in 1992.

Mr. Vander Linden served as the Acting Market Administrator during Federal order reform for more than two years prior to Dr. Nicholson's appointment as Market Administrator for the Central Order. In addition, he held the position of Acting Market Administrator since Dr. Nicholson's retirement.

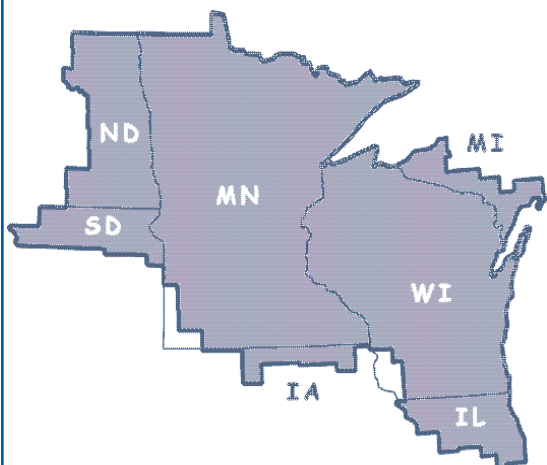
