
Cheese Prices Rebound, but Butter Falls

Prices for cheddar cheese on the Chicago Mercantile Exchange (CME) rebounded sharply in the first half of November and traded briefly above \$2.00 per pound, while the butter price dropped below \$1.70 a pound.

The CME barrel price on November 17 was $1.99^{1/2}$ per pound, up $29^{1/2}$ ¢ from October 17, and the 40-pound block price of $1.98^{1/2}$ per pound was up $27^{1/4}$ ¢. Cheese prices were more than 55¢ above last year.

On November 17, the CME butter price closed at $1.66^{3/4}$ per pound, down $18^{1/2}$ ¢ from October 17 and $28^{1/4}$ ¢ below a year ago.

The October Federal order Class III price was \$18.03 per cwt., down \$1.04 from September, but \$1.09 above October 2010. The November CME Class III futures price on November 17 was \$19.08 per cwt., with December closed at \$18.23 per cwt. The future prices for the first half of 2012 currently average slightly above \$16.60 per cwt.

Pool Summary

- In October, producer milk totaled 2.7 billion pounds, up 33 million pounds from September, but 42 million pounds below October 2010.
- Class I utilization totaled 358 million pounds, down 4.4% from September on a daily basis. Class I usage accounted for 13.3% of producer milk.
- Class III utilization totaled 2.3 billion

pounds and accounted for 84.0% of producer milk.

- The October Producer Price Differential (PPD) was \$0.38 per cwt.
- The Statistical Uniform Price was \$18.41 per cwt., down \$1.30 from September, but \$1.24 above October 2010.
- Market statistics for October are shown on Pages 4 and 5.

Per Capita Disposition of Fluid Milk Products

n examination of per capita disposition of fluid milk products (FMP) in the Upper Midwest Marketing Area was conducted for 2010, with comparisons made to 2009. In addition, the Upper Midwest data were compared to similar data for all other Federal orders, combined.

Comparison to Other Orders

In 2010, total per capita disposition of FMP in the Upper Midwest market exceeded the average for all other Federal orders, as represented in Figure 1. In addition, a much smaller proportion of disposition is in whole milk products in the Upper Midwest Order when compared to all other Federal orders. These findings are consistent with trends that have been observed in the Upper Midwest region in previous years.

Total per capita disposition of FMP in

the Upper Midwest Order averaged 211 pounds in 2010, down three pounds from 2009. In 2010, 13% of the total was disposed of as whole milk products and 87% as lowfat products, unchanged from 2009.

This compares to an average for 2010 of 175 pounds per capita for all other Federal orders. In 2010, the whole milk portion accounted for 28% of total disposition, while lowfat accounted for 72%, a shift of 1 percentage point from 29% and 71% respectively in 2009.


Upper Midwest Order Trends

Several changes in per capita disposition of FMP in the Upper Midwest market have taken place between 2000 and 2010, as represented by Figure 2 on Page 3.


Total FMP disposition dropped from 225

pounds in 2000 to 217 in 2004 and rebounded slightly to 220 pounds in 2007. Since then, the decline has resumed and total FMP disposition fell to 217, 214 and 211 pounds in 2008, 2009 and 2010, respectively. In addition, changes in the proportion of whole milk products versus lowfat milk products occurred during the period.

Per capita disposition of whole milk products was 27 pounds in 2010, down 13 pounds from 2000. However, during this time, disposition of lowfat products declined from 185.5 pounds in 2000 to 179 pounds in 2004, then rebounded to 188 pounds in 2007, but fell to 184 pounds in 2010. As a result, whole milk products accounted for a smaller proportion of total disposition in 2010 than they did in 2000. In 2010, whole milk products accounted for 13% of the total, down from 18% in 2000.
