Dairy Prices Mixed in July, Below Last Year

Cheese prices are mixed as of July 18 on the Chicago Mercantile Exchange (CME), with blocks up, but barrels still down from June. Meanwhile, butter is up from June, but both nonfat dry milk (NFDM) and whey were down from last month. All commodities were lower than their prices last year at this time, as shown in **Figure 1** on Page 2.

The CME barrel price on July 18 for cheddar cheese was \$1.45¾ per pound, down 6¾¢ from June, and 55¼¢ below last year. Meanwhile, the 40-pound block price for cheddar cheese on the CME on July 18 was \$1.58½ per pound, up 21¢ from last month, but 39¢ down from a year ago.

The CME butter price on July 18 was \$2.56 per pound, up 19½¢ from last month, but 40½¢ below last year.

The July 18 CME price for nonfat dry milk (NFDM) on the CME was \$1.10 per pound, down 5¾¢ from June, and 59¢ below last year. NFDM has been on steady decline since last July.

The CME whey price on July 18 was \$0.24 per pound, down 3½¢ from last month and 22½¢ below last year.

The Federal order Class III price for June is \$14.91, down \$1.20 from May, and down \$9.42 from a year ago. This is the lowest the price has been since May of 2020.

The July 18 CME Class III futures market has the price declining to \$13.86 for July, and steadily rising to \$17.81 to close out the year in December.



Pool Summary

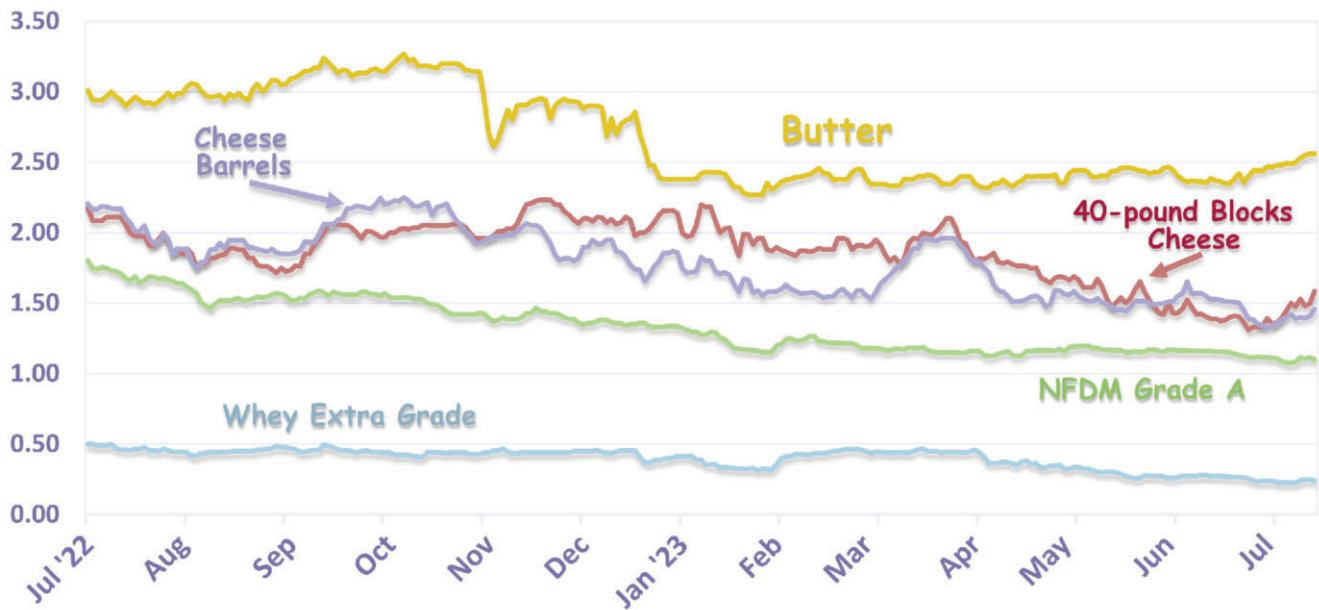
- In June, producer milk was 2.7 billion pounds, up 1.3% daily from May and up 10% from last June.
- Class I use was a record low 149 million pounds, down 5.1% daily from May and 9.1% below last year. In June, Class I use was 5.4% of total producer milk.
- The June 2023 Producer Price Differential (PPD) was \$0.36 per cwt.
- The F.O. 30 Statistical Uniform Price in June was \$15.27 per cwt., down \$1.22 from May, and down \$9.36 from last year.
- Market statistics for June are shown on Pages 4 and 5.

Supply Plant Systems

Supply plants are defined in §1030.6, with performance requirements defined in §1030.7(c). In general, supply plants are required to ship 4.5% of their receipts to bottling plants, as revised on August 1, 2022. These performance requirements can be met as a “system”, as defined in §1030.7(f).

This provision allows two or more supply plants operated by one or more handlers to qualify for pooling by meeting the shipping requirements in the same manner as a single plant. In other words, an individual plant in a system does not need to qualify on its own, as long as the system as a whole qualifies.

Supply plants in a system must be located in the marketing area.

The following supply plants requested system pooling for the period of August 2023 through July 2024. The only supply plant system in the coming year was formed by Central Milk Producers Cooperative.

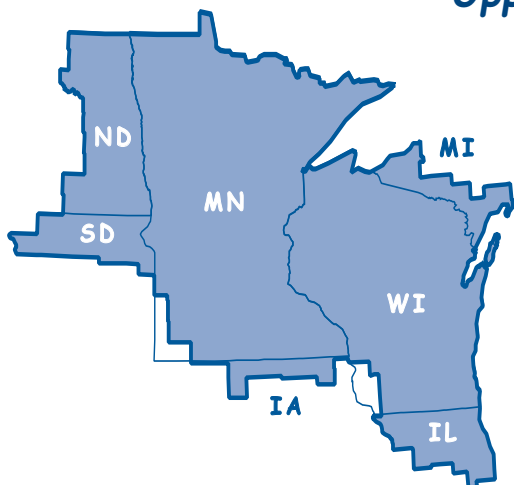
